**Rules and Regulations:**

- 1) These Rules and Regulations are in addition to the Village of Westfield Center Park Rules applicable to all parks and facilities. In addition to these Park Rules, all Ordinances of the Village of Westfield Center are applicable and enforceable.
- 2) In order to prevent injury and to prevent damage to the park, the applicant and all participants (and/or guests) are expected to conduct themselves in a safe and respectful manner.

- 3) The applicant or organization sponsoring the event must be cognizant of weather conditions and cancel, postpone, or cease activities in the even to inclement or unsafe weather. The applicant or sponsor organization should have plans in place to protect the safety of participants and spectators from all unsafe conditions.
- 4) All rain-out games MUST be rescheduled through the Village Hall at 330-887-5151.
- 5) All Coaches and Players must adhere to dug-out rules and regulations posted inside dug-out and all Park Rules.
- 6) Pets are to be kept out of fenced in ball fields.
- 7) The Village is not responsible for any lost items or stolen items.
- 8) Gates are to be used to enter and exit the ball fields.
- 9) Dugouts and surrounding park areas are to be kept clean. Do not liter.
- 10) Concession areas are to be cleaned and all trash removed at the end of an event.
- 11) **PARK CLOSES AT DUSK.**
