I further agree to indemnify and hold harmless the Village of Westfield Center and their agents and employees from and against all claims, damages, losses and expenses, including attorney fees arising out of or resulting from the utilization of the park, provided that any such claims, damage, loss or expense is attributed bodily injury, sickness, disease or death, or to injury to or destruction of tangible property including the loss of use resulting there from; and is caused in whole or in part by any negligent or willful act or omission of the undersigned or anyone directly or indirectly in the park as a result of the undersigned's authorized activity for whose acts the undersigned shall be liable.

It is further understood and agreed that the undersigned shall, at the option of the Village of Westfield Center, defend the Village of Westfield Center with appropriate counsel and shall further bear all costs and expenses, including the expense of counsel, in the defense of any suit arising as a result of the undersigned use of the park.

The undersigned acknowledges and agrees that all activities shall be conducted in accordance with the rules and regulations of the Village of Westfield Center and that a copy of said rules and regulations have been provided to the undersigned. Applicant shall be responsible for making all participants aware of the rules and regulations and compliance therewith.

# VILLAGE OF WESTFIELD CENTER PARK RULES

## (Applicable to all Village Parks/Facilities)

- 1) The applicant and all participants/guests are expected to conduct themselves in a safe and respectful manner, to prevent injury to one another and to prevent damage to park property. In addition to these Park Rules, all Ordinances of the Village of Westfield Center are applicable and enforceable.
  - 2) The following are **prohibited** on Village Park property:
  - Alcohol or Illegal Drug use of any type.
  - Motorized vehicles or conveyances except those authorized by Village authorities or those utilized by special needs citizens.
  - Unleashed pets. Persons in control of the pet are required to remove and properly dispose of the pet's
    excrement.
  - Amplified sounds or music, unless prior written approval of the Village is obtained.
  - Littering.
  - Disorderly Conduct/Disturbing the Peace.
  - Solicitation or distribution of handouts including posting of signs.
  - Unauthorized commercial activity.
  - Damaging, defacing or altering any park property.
- 3) The Westfield Center Police Department patrols the parks throughout the Village and enforces all park regulations. Violators of Park Rules or Village Ordinances are subject to fines up to \$250.00 per offense.
- 4) A refundable deposit of \$\_\_\_.00 may be required from anyone who utilizes parks in the Village to assure that the park land and facilities are returned to the Village in the same condition as taken by the permittee.
- 5) A copy of the Park Reservation & Permit, and, if applicable, the Sports Field Rental Application, must be on the park site at all times during the event and produced when requested by a police officer or Village employee/official.
