## AN ORDINANCE AMENDING ORDINANCE 2023-02 THE 2023 PERMANENT APPROPRIATIONS AND TO SET THE FINAL APPROPRIATIONS FOR THE VILLAGE OF WESTFIELD CENTER FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2023 AND ENDING DECEMBER 31, 2023, AND DECLARING AN EMERGENCY.
